Growing from a good idea without a method into a wellrespected agency serving hundreds of consumers is no small task, and we will begin to look at ways to both publicize and celebrate this anniversary with all our stakeholders.

This year is going to be a challenging one for our entire field. The changes and transformation of everything we do will continue to move ahead in 2016. We have already seen some of the changes and I anticipate there will be major decisions to be made in 2016.

For instance, *fee for service Medicaid* will be replaced by choosing from various Managed Care Organizations. Not surprisingly, the sole purpose of this is to save money. What it means in practice for a sick CLC consumer in the middle of the night is yet to be seen. Only time will tell.

Public hearings on NY's Waiver Plan to the Federal Government are planned for the end of January. It's a huge, complex undertaking and one which will shape how our country will care for citizens who cannot advocate for themselves. I anticipate that there will be a great deal of information flowing before and after the hearings this month, and I will share or post the relevant pieces.

There is a small group of concerned parents and consumers who have expressed a willingness to help with advocacy issues. We will be getting together soon and there is always room at the table for additional help.
