## ADI ON A MISSION Annette Maksoud

Advocates for the Disabled, Inc. (ADi Cares) was launched by Rochelle Hutchings in 2004 as an Independent Medicaid Service Coordination Agency serving developmentally disabled adults. ADi was dedicated to providing the highest quality of service coordination protection and advocacy for the developmentally disabled. The organization worked diligently to provide maximum independence and community inclusion, while respecting individuality.

#### These services were provided by:

-Coordination and collaboration of the delivery of services for the needs of persons with developmental disabilities; -Ensuring that individuals and/or their

families and advocates received all services to which they were legally entitled and which allowed them to have the highest quality of life;

-Making certain that individuals with developmental disabilities are treated with dignity and respect, and that their residences were safe and secure.

In 2019, New York State opened Care Coordination Organizations (CCO) that forced independent coordination

agencies to choose which CCO to enroll individuals. ADi transferred over 400 clients to Lifeplan CCO. Amy Berman, as the Executive Director. oversaw the smooth transition for the individuals and their families. Amy also aided in hiring or transitioning ADi's current Social Workers/Care Managers over to their organization. After the transition, ADi and its Board proposed that ADi provide administrative and compliance duties for the CLC Day Hab Program.

ADi has achieved major accomplishments throughout the years. Deirdre Tracey, was assigned as the Program Coordinator in June of 2019. She organized and created the compliance from scratch, researching all the requirements from OPWDD and working closely with the program specialists.

Deirdre works with over 90 Care Managers on a regular basis. She works hand in hand with the Program Specialists at Community Connection Life (CCL) and with Winslow Therapeutic Riding Center, with which she has formed strong working relationships. Deirdre has recently been promoted to Director of Day Hab.

Another major accomplishment has

been significant program growth. The program and staff have expanded tremendously due to the collaboration between ADi. CCL and Winslow. This truly has been a team effort.

One last accomplishment to be highlighted is their pride in ensuring that policies and procedures were put in place.

When asked what is one of Deirdre's short-term goals, she replied, "I am eager to form positive working relationships with my growing team and enhance communication."

As for long term goals, CLC is looking to expand services and ADi will be there to assist. Effective September 1, 2022, Amy has assumed the role of Executive Director of Community Living Corporation (CLC). She is excited about her new role.

Amy has known and worked with the staff, individuals and their families for many years. Amy says, "I am passionate about this field and the work we do with the individuals we serve. I look forward to embarking on this new mission."

Second, on September 13th, The New York Assembly Standing Committee on People With Disabilities, conducted a Public Hearing aimed at gathering feedback from both Commissioner Kerri Neifeld, the Assembly members and the system stakeholders. This hearing was aimed at fulfilling one requirement of Mental Hygiene Law, Section 5.07.

With this action. OPWDD has begun the creation of it's five-year plan, due in November. This plan is crucial because it is the vehicle by which the budget is created and then utilized for the next five years. I was moved by the many, many discussions regarding the need for a stable workforce earning a living wage. There is no doubt in my mind that every person participating in this hearing is now fully educated regarding the needs and realities of the DSP workforce.
